**ORDER**

**WHEREAS**, in terms of Section 14(1) of the NCTE Act, 1993, **Women's Training College, Patna University, North Gandhi Maldan, Patna, Bihar-800001** has applied for grant of recognition for B.Ed. Course was received by Eastern Regional Committee of NCTE on 24.06.1996.

2. **AND WHEREAS**, the institution was granted recognition for B.Ed. course vide order dated 11.02.1997 from the academic session 1997-98 with an intake of 80, order dated 22.02.1999 from the academic session 1999-2000 with an intake of 120 by the ERC, NCTE, followed by revised order vide No.32510 dated 30.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

3. **AND WHEREAS**, the ERC in its 244<sup>th</sup> Meeting held on 08<sup>th</sup> - 09<sup>th</sup> October'2017 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn U/s 17(1) of NCTE Act, 1993 vide order No.ER-244.17.8/(BR-S/E-5/96)/B.Ed./2017/54769 dated 23.10.2017 from the next academic session.

4. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the withdrawal order of ERC and the Appellate Authority vide order No.89-383/E-76994/2018 Appeal/14<sup>th</sup> Mtg.-2018/30<sup>th</sup> & 31<sup>st</sup> July, 2018/68859 dated 07.08.2018 decided to set aside the order of withdrawal dated 23.10.2017. The appellant is however, required to submit to ERC, a complete and comprehensive list of faculty as per norms and standards of NCTE Regulations, 2014 along with the action plan to conduct the course uninterruptedly when temporarily appointed full time faculty is replaced by regular faculty recommended by Bihar Public Service Commission in due course.

5. **AND WHEREAS**, the ERC in its 260<sup>th</sup> meeting held on 260<sup>th</sup> meeting on 31<sup>st</sup> August - 01<sup>st</sup> September'2018 re-viewed the matter in accordance with the appeal order and accordingly, Show Cause Notice was issued on 11.09.2018 to the institution. Replies dated 29.09.2018 and 24.10.2018 in response to SCN received from the institution was considered by ERC in its 263<sup>rd</sup> meeting held on 15<sup>th</sup> - 16<sup>th</sup> November'2018.

**In view of the above, the Committee decided as under:**

Recognition to B.Ed. course be continued from the academic session 2018-2019.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition / permission by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
